- 1. Holiday pay was omitted from paychecks, but was corrected with paper checks dated for payroll date of June 16, 2023.
- 2. Hillsdale water well at 153 Hillsdale Gumpond Rd. was hit by a lighting strike during a severe thunderstorm on June 12, 2023 and the situation is being assessed and repairs are being made. Insurance company has been notified of the situation via email on June 13, 2023, but no claim has been filed to date.
- 3. Still in process of purchasing Dillard Property near Circle Dr. in Picayune, MS
- 4. Attended MS Gulf Coast Grants Seminar and planning on a July 28, 2023 submission for grant for expansion of Wildwood Drip Field. Grant proposal will be presented to the board for approval prior to submission.
- 5. Contractor given final punch out list today, June 15, 2023 for the new Administration Building.
- 6. Furniture for the new Administration Building has shipped and is slated to be delivered sometime within the next two weeks.
- 7. PRCUA 3D 36" Crest for the board room at the new Administration Building should be shipped and installed soon.
- 8. Still in the process of hiring a new employee for the Collections team. This is contingent on Allen Black passing the exam and moving to the Water Operator position.
- 9. Attended the Gulf Coast Utility Board Meeting. This was set to be their final meeting, however the Legislature extended the board through 2027.
- 10. Considering JCL for grass maintenance at levees, lagoons, and right of ways.
- 11. Looking into better health insurance options for employees for upcoming renewal.
- 12. Scheduled a round-table meeting with the collections team for Thursday, June 22, 2023 to address the following:

  - b. Standardizing vehicle equipment
  - c. Standard response procedures
  - d. Work order requirements on updates
